Rules & Regulations:

1. Transport facility cannot be claimed as right. It will be decided by the school management depending on feasibility.
2. Transport facility once opted cannot be cancelled. Fees once paid will not be refundable under any circumstances.
3. In case the Government orders that the classes will be run in online mode only and not in offline mode due to COVID situation or otherwise, there will be no fee refund given and no adjustment in fee will be done in any case.
4. In case the child is dropped by the parents to the school or collected by the parents from the school the fact must be brought to the notice of the concerned driver/ conductor through the school office /transport in charge.
5. The transport facility can be withdrawn if the student availing the transport exhibits any kind of indiscipline.
6. Transport facility only be provided at prescribed routes. Wherever it is not possible for the vehicle to enter or exit due to short roads / uneven roads / practical difficulties, the transport facility will be available to the nearest main road stop.
7. Transport facility will only be provided in the regular school time on school working days.
8. Please attach one photograph on the transport form and one photograph is to be submitted along with the form.
9. The charges for transport facility depends on various external factors including but not limited to seating capacity, fuel prices, insurance, permit, government regulations, etc. and therefore are liable to change in future. Decision of management and school authorities are final and binding in this regard on parents.
10. Transport facility charges are for one Academic Session and the transport facility cannot be taken month wise / quarter wise / any other manner. The charges are for entire Academic Session for working school days (excluding all holidays, government notified holidays, winter / summer breaks).
